WE BELIEVE the Holy Bible to be the inspired, only infallible, authoritative, Word of God. (II Timothy 3:15; II Peter 1:21)

WE BELIEVE there is one God, eternally existent in three persons - Father, Son, and Holy Spirit. (Genesis 1:1; Matthew 28:19; John 10:30)

WE BELIEVE in the deity of Christ (John 10:33)
His virgin birth (Isaiah 7:14; Matthew 1:23; Luke 1:35)
His sinless life (Hebrews 4:15; Hebrews 7:26)
His miracles (John 2:11)
His vicarious and atoning death (I Corinthians 15:3; Ephesians 1 :7; Hebrews 2:9)
His resurrection (John 11:25; I Corinthians 15:4)
His ascension to the right hand of the Father (Mark 16:19)
His personal return in power and glory. (Acts 1:11, Revelation 9:11)

WE BELIEVE that God created each person male or female and those cannot be changed or altered. Rejection of one's biological sex is a rejection of the image of God within that person. (Genesis 1:26-27; Romans 1:24-27)

WE BELIEVE That all human life is sacred and created by God in His image. It is of inestimable worth in all dimensions, including pre-born babies, the aged, the physically or mentally challenged, and every other stage or condition from conception through natural death. We are called to defend, protect, and value all human life. (Psalm 139)
